### **Disclosure of Risk**

I, \_\_\_\_\_, the undersigned for myself or on behalf of my child or legal guardian of the person named below, do voluntarily request to participate in Equine Activities, namely The Horse and Mule Show, sponsored by The Cedar Grove Ruritan Club.

I understand that participating in The Horse and Mule Show is inherently dangerous and can result in injury or death.

I accept that equines frequently behave in unpredictable ways to sounds, sudden movement, unfamiliar objects, persons and other animals.

I understand that surface and subsurface conditions contribute to equine risk and injury.

### **Helmet Awareness**

I have been advised to wear a helmet or hard hat (preferably ASTM/SEI approved) as it will substantially reduce my risk of head injury.

### **Release from Liability and Waiver of Right to Sue**

The undersigned agrees that the Cedar Grove Ruritan Club, its members, officers, chairmen, and employees (whether paid or volunteer) and any other and all other persons, firms, corporations, owners and lessees of any property or land on which the horse show takes place shall not be liable for an injury to or the death of a Participant resulting from the inherent risks of the Horse and Mule Show sponsored by the Cedar Grove Ruritan Club.

The undersigned further agrees that the Participant or Participant's representative shall not maintain an action against or recover from the Cedar Grove Ruritan Club, its members, officers, chairmen, and employees (whether paid or volunteer) engaged in Horse and Mule Show for injury, loss, damage, or death of the Participant resulting exclusively from any inherent risks of The Horse and Mule Show.
